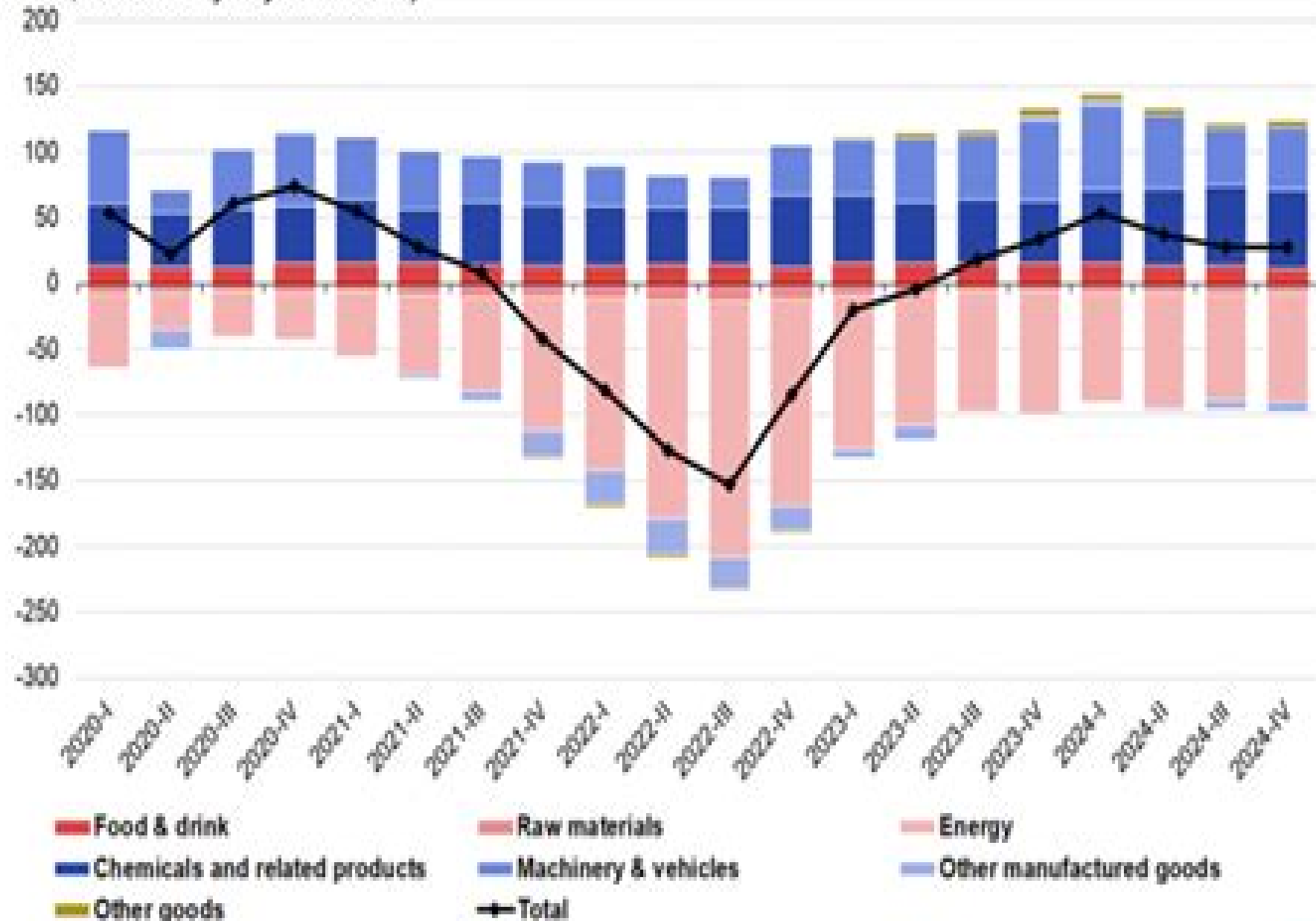


EU trade balance by product group, Q1 2020 to Q4 2024
