# The UK Environment Act 1995: Comparison to Evolving U.S. Environmental Laws

by Gary A. Lewis and Dr. Paul Nathanail

The gap that has existed. between the United States and the United Kingdom (UK) approach to evaluating and addressing environmental problems created by past contamination is beginning to converge with enactment of the United Kingdom Environment Act 1995 (UK Act). The UK Act and guidance that will accompany this legislation exhibit a number of similarities to U.S. House of Representatives Bill HR 1022 and evolving state environmental legislation that has been patterned after ASTM ES 38-94 (RBCA).

#### The UK Environment Act 1995

The UK Act contains provisions with respect to contaminated land intended to improve clarity and consistency in identification and remediation of such land; it amends and updates the Environmental Protection Act 1990. The UK Act provides the first British legal definition of contaminated land. This definition states that contaminated land is:

"... any land which appears to the local authority in whose area it is situated to be in such a condition, by reason of substances in, on, or under the land, that

- (a) significant harm is being caused or there is a significant possibility of such harm being caused;
- (b) pollution of controlled waters is being or is likely to be, caused . . . . "

The UK Act will be accompanied by British Secretary of State Guidance (Guidance) that has been published in draft form but does not yet have the force of law. The Guidance will undergo a formal review and public consultation period prior to being published later.

The UK Act states that it is the responsibility of the local authority to identify contaminated land and to direct action necessary to block "significant harm" or "potential significant harm" that may result from the contaminated land. The Guidance provides definitions and a procedure for the local authorities to follow in their identification of contaminated land and on an appropriate response to land identified as contaminated. Terms such as "significant harm" and "significant possibility of harm" are defined in the Guidance.

The UK Act and Guidance are based upon established UK government policy as outlined in "Framework for Contaminated Land" (Framework) published by the UK Department of Environment (DoE) in 1994. The Framework sets the foundations of UK contaminated land policy including the concepts of "suitable for use," "risk assessment," and "prioritization."

The policy with respect to "suitable for use" states the following: "The government is committed to the suitable-for-use approach to the control and treatment of existing contamination . . . by reducing the damage from past activities and
