Furthermore, the codified systems of property rights which largely excludes Indian Fijians from the ownership of land was established by the British. It has been a major source of ethnic tension and of social and political conflict in Fiji. We show that this system of property rights has had important negative consequences for economic growth in Fiji, for the economic performance of its industries and for the conservation of its natural resources, natural resources which may not be equitable and which also does not appear to be efficient administratively. This adds to social and political tension in Fiji.
