Rather, its individual member nations drove the warfare often attributed to the whole, creating a shifting, amorphous political and military position that allowed member nations to pursue separate policies of war and peace against common foes and multiple enemies. Unconquered also seeks to dispel longstanding beliefs about the invincible Iroquois empire, myths that have been dispelled by focused academic studies but still retain a powerful resonance among popular conceptions of the Iroquois League. While the Iroquois created far-reaching networks of trade and destroyed or dispersed Indian peoples along their borders, they created no expansive territorial empires. Nor were Iroquois warriors unequalled in battle. Europeans, Americans, and Indians defeated Iroquois warriors and burned Iroquois villages as often as they tasted defeat, and on more than one occasion they brought the Iroquois League to the brink of utter ruin.
