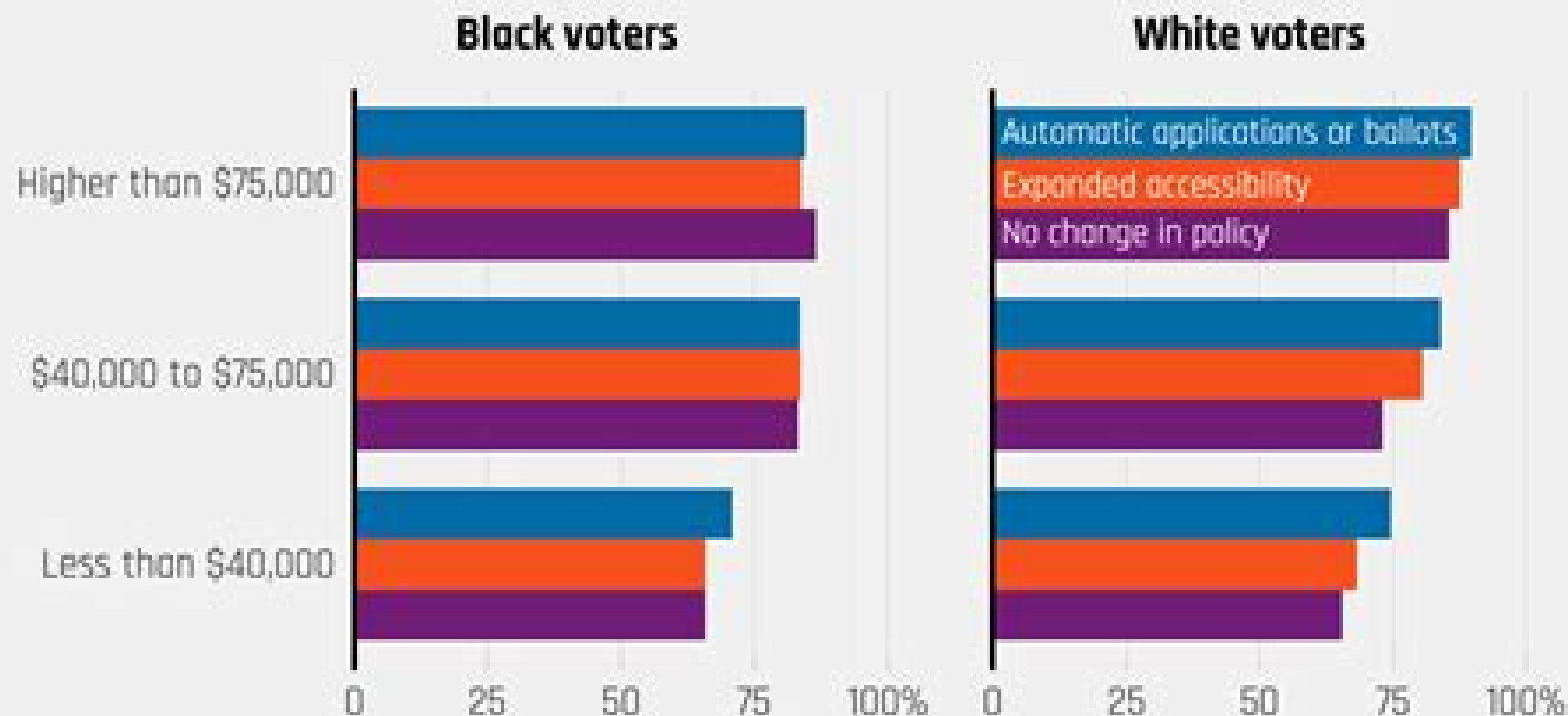


Middle- and high-income Black individuals voted at about the same rate, regardless of state vote-by-mail policies
