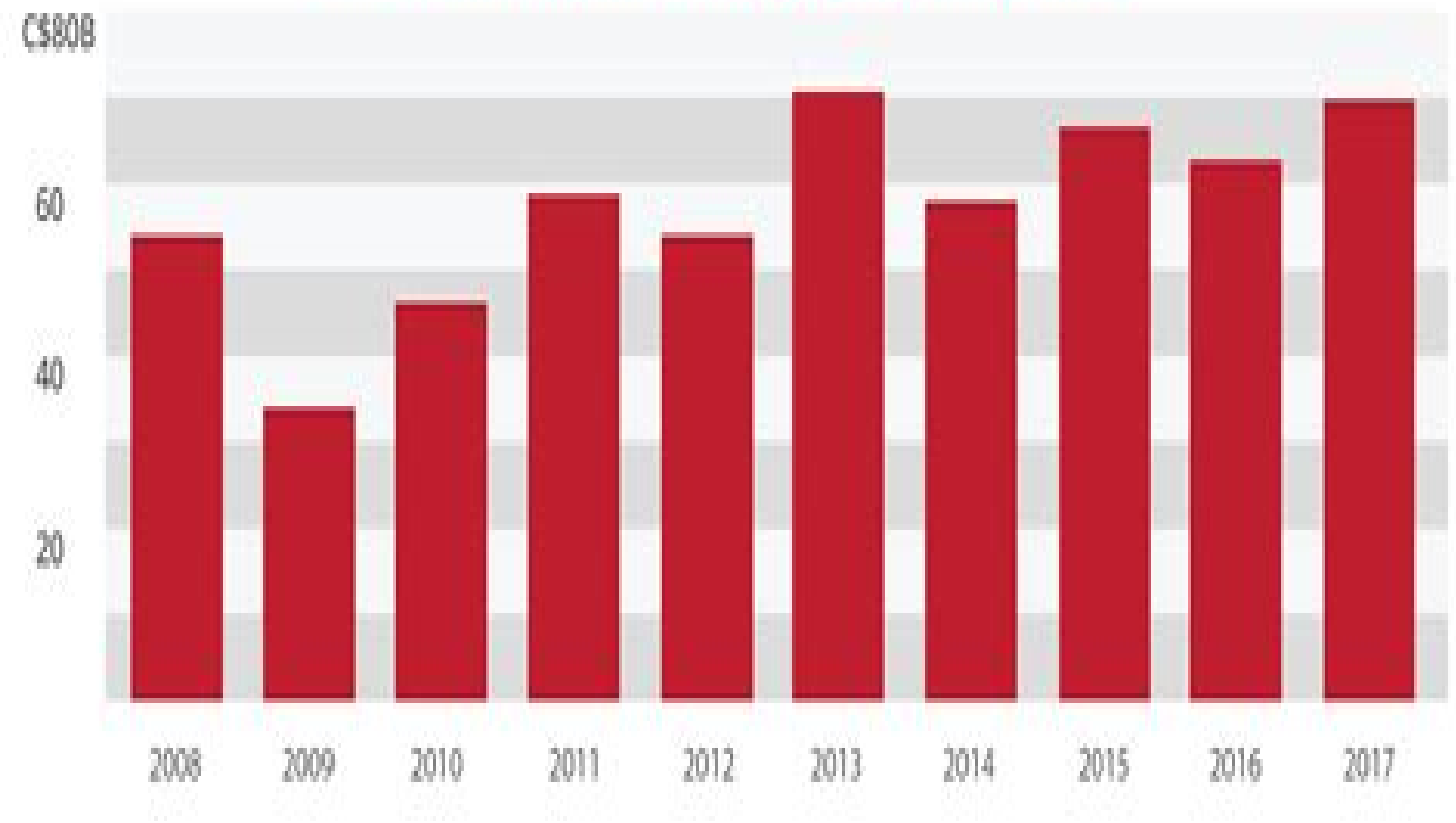

positively associated with an increase in short term debt financing Quantile regressions suggest that there is substantial heterogeneity among firms on how they react to macro financial conditions large increases in long term debt financing and large declines in short term debt financing tend to be driven more by better macroeconomic performance while large increases in short term debt financing are more strongly impacted by tighter financial conditions Since the paper uses data up to 2017 it does not reflect developments that occurred during the coronavirus pandemic Nonetheless sensitivity analysis shows that a significant amount of corporate debt representing more than 5 percent of GDP could be at risk in some countries with an adverse spillover to the financial system if financial conditions tighten or economic growth slows down This suggests that vulnerabilities should be closely monitored and policy action taken if warranted
