including housing subsidies Hebrew language training and vocational education This episode provides a natural experiment for testing the consequences of a large immigration inflow of skilled workers This book provides a detailed analysis of the gradual process of occupational upgrading of immigrants and the associated rise in their wages Based on their analysis the authors conclude that even a very large and unanticipated wave of immigration can be integrated within the local labor market without any significant long term adverse economic effect on natives The small effect on wages and employment of natives is explained by the capital inflows into Israel and the gradual entry of immigrants into high skill jobs as they invest in local human capital An important contribution of the book to the immigration literature is the formulation and estimation of stochastic dynamic models that combine job search with investment in human capital and the analysis of alternative government policies within this framework
