- With Sixth Five Year Plan(1980-85), the 1980s saw the beginning of changes in economic policy with greater flexibility being given to the private sector, and freer access to imports for exporters, combined with a conscious effort at managing the exchange rate to avoid exchange rate appreciation in real terms.
- In Seventh Five Year Plan(1986-90), policies towards the private sector were made more supportive and the tax system was rationalised. By 1988 all industries were delicensed except for 32 industries.
