When Richard Ellmann's biography of James Joyce first appeared in 1959 it was widely and correctly hailed as a classic in biography, the authoritative work on the life of Joyce, and a delight to read. Now, in 1982, the centennial year of Joyce's birth, Oxford University Press has issued a revised and expanded edition with 100 new pages of information and 80 new illustrations that attest to the continued devotion of Professor Ellmann to the subject. Anyone who is even remotely interested in the literature of the twentieth century—as I hope will include anyone who practices psychotherapy—will find this to be mandatory reading, especially if he or she is not familiar with the 1959 biography.

The style continues to be delightful and fully definitive on the subject and, above all, it deals with the entire intellectual thrust of western Europe in the first half of the twentieth century. The strange story of Joyce and his deep immersion in the world of dreams and the unconscious, interwoven with the literature he produced, is of paramount interest to us. In addition Joyce somehow managed to connect together the whole literary effort of western man from Homer to the present day to present and transcend the growing self-consciousness of our existential plight. He also made important breakthroughs of his own in this tradition, based on his incredible genius in the use of words, knowledge of languages, and profound erudition; his only equal in this adventure was Ezra Pound, who was one of the first to recognize his greatness. I can recommend Ellmann's re-telling and portrayal of Joyce's personal and artistic adventure to all our readers without reservation.

THOMAS McGuire: Financing Psychotherapy: Costs, Effects, and Public Policy. Ballinger Publishing Company, Cambridge, Mass., 1981, 241 pp., \$15.00.

Professor McGuire is an economist who feels quite at home in applying his speciality to the complex area of insurance coverage for psychotherapy. As might be expected, he assumes that a cost-effectiveness approach is an acceptable measure of worth in regard to psychotherapy and seemingly subscribes to the notion that the old adage "less is more" applies equally well to psychotherapy as it was supposed to have done for architecture. To put it bluntly, the author's ignorance about the differences between brief and long-term psychotherapy, intensive and superficial psychotherapy, psychoanalytically derived psychotherapy and psychoanalysis leads him to view all psychotherapies and all psychotherapists as equally valid and effective. Psychotherapy is reduced to a commodity that can be delivered equally well by a psychiatrist, psychoanalyst, social worker, nurse practitioner or mental health worker.

For McGuire, the fact that he has accepted psychotherapy as a necessary ingredient in the armamentarium of treatments that should be available to the broad public seems to be sufficient. Beyond this, his concerns are only those of an individual who mistrusts and misunderstands anything resembling intensive psychoanalytic psychotherapy.

Beside serving to alert those of us in the field who worry about the fate the federal health planner might have in store for us, Financing Psychotherapy gives the economically minded psychiatrist an excellent opportunity to glimpse how an
