Agricultural Policy is kept unchanged focusing on activities that maximize positive externalities and reduce costly duplication can generate net positive values for member states Second reforms are needed to make the budget more streamlined responsive to evolving needs and more effective by incentivizing good performance Lastly the financing framework should be strengthened by integrating borrowing as a regular tool alongside greater own resources to bolster debt service capacity Increasing own resources by about 0.2 percent of GNI annually to cover peak debt servicing costs along with additional reserves for unexpected challenges would likely provide financial security to support the proposed increase in the budget A clearer focus on strategic investments and measurable outcomes will reinforce the budget's positive sum value helping build support for a more ambitious EU budget
