An ownership stake in a company

A financial contract whose value is derived from an underlying asset

Purpose

To own a share of a company's assets and profits To hedge risk or speculate on the future price of an asset

Examples

Stock, common share, preferred share

Futures, options, swaps

Ownership

Owners have a claim on the company's assets and profits Derivative holders do not have awnership of the underlying asset.

Risk and Return

May involve higher risk and potential for higher return May involve lower risk and potential for lower return
