## Definition

An ownership stake in a company

A financial contract whose value is derived from an underlying asset

## Purpose

To own a share of a company's assets and profits

To hedge risk or speculate on the future price of an asset

## Examples

Stock, common share, preferred share

Futures, options, swaps

## Ownership

Owners have a claim on the company's assets and profits

Derivative holders do not have ownership of the underlying asset

## Risk and Return

May involve higher risk and potential for higher return

May involve lower risk and potential for lower return
