international law and international organizations The theme is slowly developed that in the long run national interest is better served not by practicing power politics and relying on the use of threat of force but by strengthening those international institutions that can provide a neutral environment for first slowing down a crisis and then finding an equitable solution acceptable to most of the parties in conflict The value of this book lies primarily in giving the reader a real insight into several important issues of today that are familiar to most people only from newspaper headlines and television news While not everybody can agree with all his criticisms of the mistakes of various governments there is an honest attempt by the author to present issues impartially and to let the blame fall where it may Being both an international lawyer and a political scientist the author has had the advantage of combining the methodology of these two social sciences into a rich tapestry with some startling shades and tones World Politics in a New Era Steven L.
