From the mid-1960s until around 1990, the quality of working life was a major concern. This was the era of humanistic psychology, the critique on scientific management as excessive control, sociotechnical experiments, humanisation of working life and, in Scandinavia and the Netherlands, anti-Tayloristic legislation on working conditions.

After 1990, the quality of working life faded from the political and research agendas as concerns about international restructuring, job insecurity, unemployment and lack of competitiveness became more important. In a refreshing move, this edited collection of conference papers puts quality of working life back on the agenda, but now linked with the pressing issues of globalisation.

Volker Telljohann outlines these links as follows. The best way for Europe to deal with the predicaments of globalisation is betting on quality. This is the 'high road' of international competition where quality of output and quality of working life are mutually reinforcing. The high road promises a socially responsible approach to the insecurities caused by economic restructuring.

Questions that have guided the authors include: to what extent are companies actually choosing the high road, what opportunities exist for improvement of the quality of working life and what can the EU, national governments and unions do to make companies embrace improvement of the quality of working life.

Francesco Garibaldo notes that the 'socio-technical impulse', that started decades ago, has only in exceptional cases led to change. On the contrary, we are witnessing a rise of neo-Taylorism, which entails application of the classic principle of separation of conception from execution, but now under a regime of flexible labour. And where Tayloristic principles do not apply, the decline of regulation leads to longer working hours and intensification of work. In health care and education, bureaucratic managerial control is on the increase. Also, the balance of power between labour and capital tends to shift in favor of the latter, exacerbated by a 'breakdown in the relationship between social rights in the productive sphere and political rights as citizens'.

Creating change has been attempted, but it proved to be difficult. A popular model for development programmes is the bottom-up network. A problem associated with this model is that support tends to flow to organisations that are in a strong position, not necessarily to those organisations that would need it the most. Also, there has been little diffusion of best practices. The EU tends to latch onto trends that are already underway; bold attempts to reverse trends are lacking. And in the public sector, the sector that should be expected to be more open to interventions than the market sector, opportunities for curtailing managerialism remain unused.
