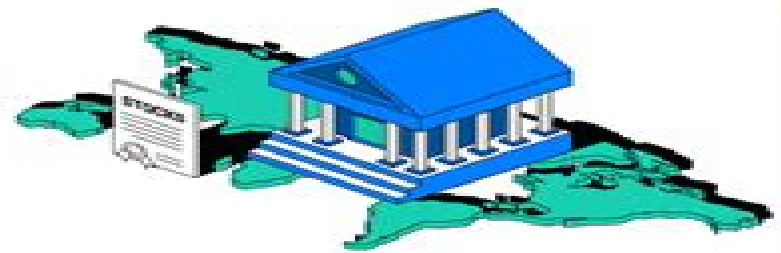

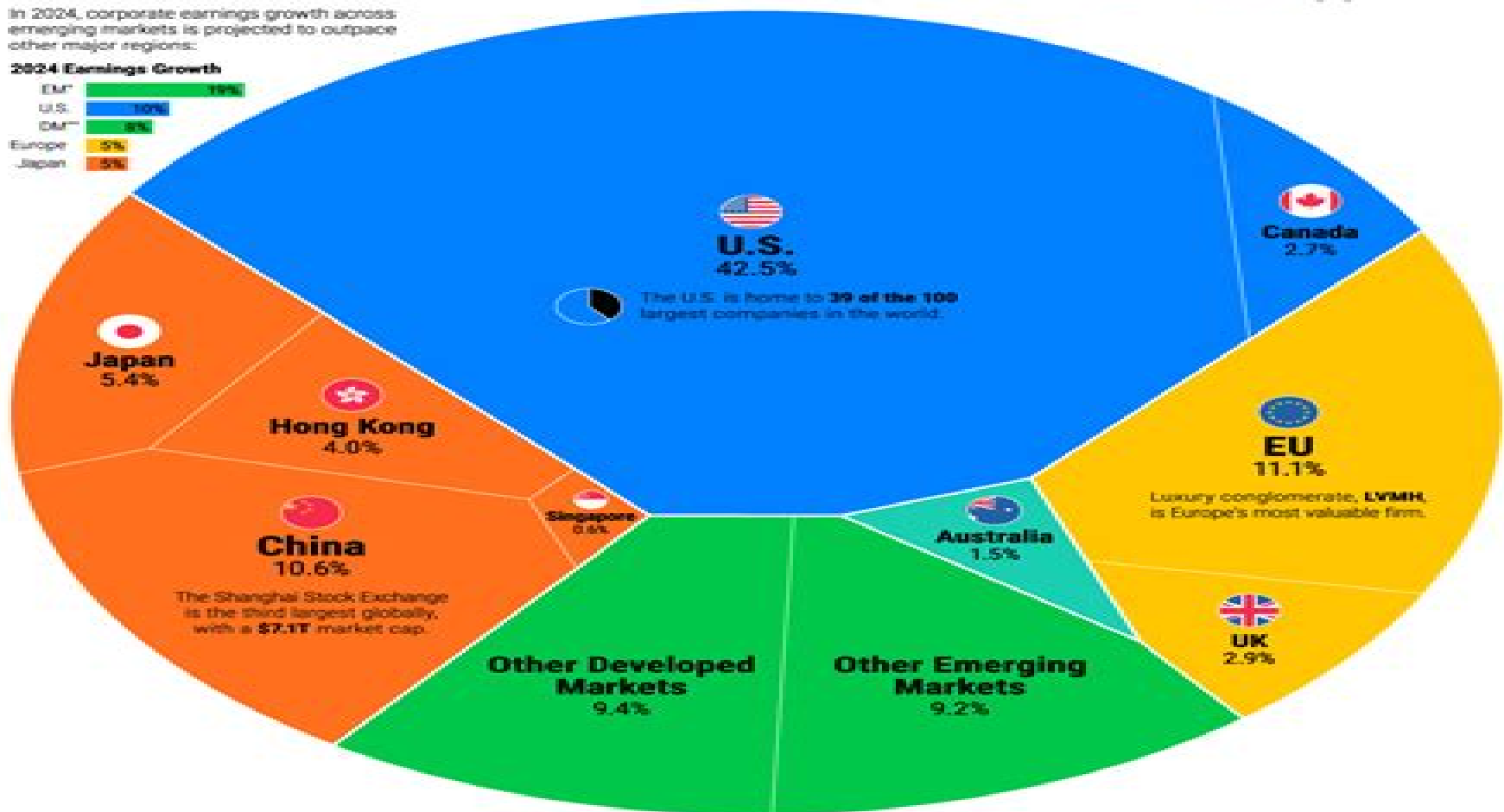


## Global Equity Market Share as of Q2 2023
