1. Introduction

Thesis or main idea. You should provoke a reaction in the reader.

3. Conclusion and closing

You will need to make another major impact. Try to reach your reader emotionally and highlight the most important points developed in the main body of your text.

2. Body of the argument

Comprising three or more paragraphs in which you outline your reasoning and data to support your view point.

First paragraph
Present the argument
you will be refuting.

Second and successive paragraphs

This is where you refute the arguments presented in the first paragraph. It is essential to communicate the arguments and data you will use to support your opinion.
