- Criterion of Interest: While public interest is at the forefront in public law, in private law individual interests are important. For example, debts arising from a sales contract. There is an individual interest in performance. In tax debt, public benefit is important, not individual. It carries.
- Sovereignty Criteria: If there is inequality between the parties, one represents public power. If it is, the public law relationship comes up. The relationship between the equals is the relationship between private law. creates.
- Forcing private parties to do something they do not want in private law relations and he cannot give orders. It is essential that the will of the parties match. Public Law. In their relations, one of the parties is the order and the other is obliged to implement it.
- Freedom of Will Criteria: As an extension of the sovereignty criterion in public law the parties cannot decide otherwise. Decisions on public law are mandatory. Private law. Most of the rules are in the form of a reserve law rule and the will of the parties is important. For example, There is a status relationship between the civil servant and the administration, determined by the rules of administrative law. However, in sales contracts, the parties can shape the contract as they wish.
