Valenstein who rejects the hypothesis that mental illness is primarily a biochemical disorder After a comprehensive review of the relevant scientific evidence Kiesler concludes that henceforth the study of mental disorders must be guided by multicausal theories and research that systematically include an array of biological psychological and sociocultural causal factors Kiesler adds that in order for this to be accomplished the mental health field and the public at large must first abandon the invalid monocausal biomedical disease model of mental disorder
