CLASSICAL CONTRACT THEORY

1. INTRODUCTION

In the 17th century Hobbes was concerned with strong government unlike Locke's interest in limiting government power.

2. Thomas Hobbes (1588-1679) Social Contractarian Response to Anarchy

In the Leviathan (1650), for Hobbes, the State of Nature prior to the formation of civil society or government was one in which all individuals were free and essentially equal in body and mind. In the State of Nature no central authority existed to adjudicate between competing interests. So people had the natural right by virtue of original freedom to determine for themselves the ends that would best contribute to their preservation.

3. The Idea of Command Positivism

For Hobbes, as long as those invested with the power can enforce the rule of law, the contract is binding; the will of the sovereign is absolute even under extreme duress.

For Locke, it was a strictly conditional trade contingent upon efficient administration of justice and peace. For Locke, the sovereign is constrained by the democratic rule of law. If the sovereign's side of the bargain is not kept, the contract is void and rebellion justified.

4. Weakness and Criticisms of Contract Theory

- The main assumption was that the contract was a real event between the sovereign and citizens at some place and definite point in the distant historical past, rather than a convenient myth as metaphor to underwrite to obligation.
