in the functioning of markets Meritocracy The concept of meritocracy refers to a system organisation or society in which people are selected and promoted to positions of success power and influence on the basis of their abilities and merits This means that an individual is able to climb the social ladder through hard work Moreover meritocracy directs the most talented people into the most functionally important positions thereby increasing a society s efficiency However the equalising function of meritocracy has been criticised Rather than reducing inequality meritocracy is seen as the cause of racial economic and social inequality
