A key finding is that improving policies paid off in higher GDR and sectoral growth rates, which are vital to reducing poverty, but in countries where policies deteriorated, economic performance worsened. The report also shows that despite the importance of reforming economic policies, countries need to invest more in human capital and infrastructure, expand their institutional capacity, and develop better governance.
