profiling is mainly used by the police to narrow down suspects in cases where no physical evidence was left at a crime scene. Recently however this technique has been introduced into the courtroom as evidence raising questions of its reliability, validity and admissibility at trial. Because offender profiling was not originally intended to be used in the courtroom its entrance there has caused both confusion and controversy. *Offender Profiling in the Courtroom* discusses the use of profiling evidence in criminal trials. Offender profiling is a crime investigation technique where information gathered from the crime scene, witnesses, victims if alive, autopsy reports and information about an offender's behavior is used to draw up a profile of the sort of person likely to commit such crime. Offender profiling does not point to a specific offender. It is based instead on the probability that someone with certain characteristics is likely to have committed a certain type of crime. In spite of the ever increasing media interest in the use of offender profiling in criminal trials this technique is still not well understood by many people including judges, lawyers and jurors who weigh such evidence at trial. Some people see offender profiling as a tried and true method of identifying suspects and others simply see it as a fiction. Here the author helps readers understand the true nature of offender profiling and the danger of its admission into criminal cases as evidence.
