It advocates for the close study of disease treatment in poor communities as an integral component of global health funding. This ethnography combines a

decade of fieldwork with critical review and a rare anthropological perspective on the limitations of the bureaucratic technological institutional medical and political practices that currently determine malaria interventions in Africa
