- Three important criteria for efficiency of property rights:
 - Universality: all scarce resources are owned by someone;
 - Exclusivity: property rights are exclusive rights;
 and
 - Transferability: to ensure that resources can be allocated from low to high yield uses.

 Note: In Demsetz' (1967) neoclassical framework, all three criteria are in place in the long-run.
