For example, there are The United Nations Declaration on the Rights of Indigenous Peoples requires States to consult and cooperate with indigenous peoples to obtain their free, prior and informed consent before undertaking development activities that might have an impact on them, whereas the United Nations Minorities Declaration contains a more general right to participate in decisionmaking and requires that the legitimate interests of persons belonging to minorities should be taken into account in national planning and programming.
