In 2011 she was awarded the Hans Sigrist Prize by the University of Bern for outstanding scholarship on the function of the rule of law in late modern societies and in 2018 an Honorary Doctorate by the University of Edinburgh. In 2017 she was awarded a CBE for services to Law, Justice and Gender Politics.
