All the economies that were under the transition process had enforced various reforms and had undergone major structural changes for embracing a market economy. Indeed, even today, many developing countries and regions are under a transition process. Lately, the nations and regions are trying to attain sustainable economic development by giving due regard to the environment under the current climate change scenario taking into consideration the overexploitation of resources and greenhouse gas emissions.
