They also contain many types of instructions such as conveyances of land, marriage contracts, wills, sheriff's sales, deeds of gifts, plats or surveys. A facsimile of some is included in these abstracts: bills of sale, mortgages, affidavits, powers of attorney, slave sales, and others.
