What you need to know

All workers have a right to work in places where risks to their health and safety are properly controlled. Health and safety is about stopping you getting hurt at work or ill through work. Your employer is responsible for health and safety, but you must help.



What employers must do for you

- 1 Provide what could harm you in your job and the precautions to stop it. This is part of risk assessment.
- 2 As a way you can understand, employ how risks will be controlled, and tell you when it is impossible for this.
- 3 Consult and work with you and your health and safety representatives or providing someone from home in the workplace.
- 4 Free of charge, give you the health and safety training you need to do your job.
- 5 Free of charge, provide you with any equipment and protection (clothing you wear), and ensure it is properly looked after.

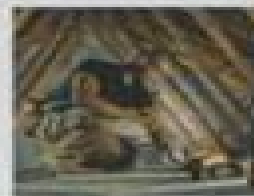


- 6 Provide safety, working facilities and working areas.
- 7 Provide adequate first aid facilities.
- 8 Report injuries, illnesses and dangerous incidents at work to our Incident Contact Centre

- 9 Have measures that prevent you or your colleagues from getting hurt or ill through work. Illnesses or health problems or dangerous work or the relevant measures could be when you can easily read it.
- 10 Work with any other employers or contractors sharing the workplace or providing equipment (health or safety measures), so that everyone's health and safety is protected.



What you must do

- 1 Follow the training you have received when using any work where your employer has given you.
- 2 Take reasonable care of your own and other people's health and safety.
- 3 Co-operate with your employer on health and safety.
- 4 Tell someone (your employer, supervisor, or health and safety representative) if you think the work or equipment provided is putting someone's health and safety at serious risk.

- 2 You can also talk to our helpline for general information about health and safety at work.
