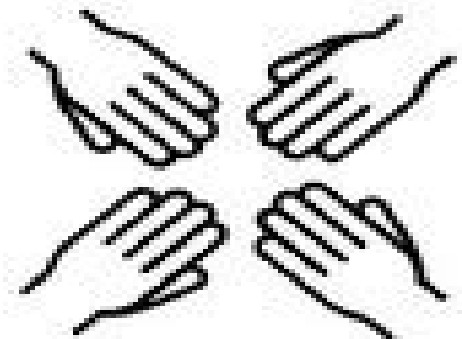
The right to education means that everyone has access to and can enjoy primary education. It also refers to the right of everyone to higher education and the without charge.
