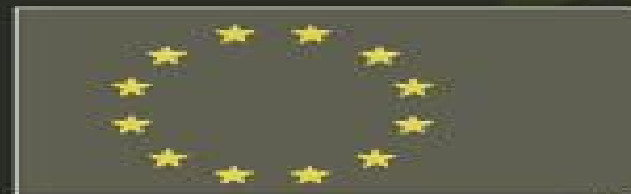

This book gives an assessment of the EMS developments and shows how financial market liberalization as well as the EC 1992 project affect the process of economic and monetary union.

Welfens The editor is pleased to present a second edition of *Economic Aspects of German Unification* which includes new chapters and several postscripts. Almost five years after unification, output in the ex GDR is back to its 1989 level. Due to a massive intra-German resource transfer, consumption per capita in eastern Germany has not fallen as much as output and employment which reduced by one fifth within three years. Given high West German transfers which represented about 5% of

West German GDP and more than 50% of East German GDP the fall of industrial output could have been much stronger than had politically been feasible Hence structural change necessary for productivity growth was dramatic in the ex GDR where the goods producing sector manufacturing mining energy and construction strongly changed its proportions within four years construction almost doubled and the share of investment goods production reduced by 10 percentage points between 1990 and 1994 and is now down to 21.1 % Mining lost two thirds of its share in the producing sector which itself was reduced relative to GDP The share of the services industry increased by 5 percentage points between 1991 and 1994 but with a share of 27.7% in East Germany's GDP it was still about 9 percentage points lower than in western Germany By contrast government accounted for 20.9% of GDP in eastern Germany but for only 13.2% in western Germany

The strong productivity growth of the US and Scandinavian countries in Europe in the 1990s has raised the question whether the ICT sector, information and communication technology that is computers plus telecommunications plus digital services, is the new driving engine of high growth in leading OECD countries. Judging by the empirical evidence for the US, including a new study by McKinsey which gives mixed evidence, it is still too early to clearly dismiss Robert Gordon's hypothesis that the acceleration of US output growth is disregarding quality problems of price measurement exclusively due to cyclical factors and increased productivity growth in the computer sector. The counter hypothesis is associated with research by Stiroh and others who argue that there are positive productivity spillover effects from ICT to other sectors. Indeed, it is not clear ex ante whether mainly the Old Economy or the so-called New Economy stands to benefit most from high innovation rates and strong productivity shifts associated with the spreading of digital services. Interestingly, the increased economic role of the internet also contributes to the internationalization of the economy since more services have become tradable and growing import competition itself could stimulate productivity growth and thus contribute to higher growth. If ICT plays a key role in the new economy, there are important implications in the differential degree to which Germany and the US have implemented ICT.
