What is Shorting?

- Object of shorting is just like going long-want to buy low and sell high
- Just need to do it in reverse order
 - ✓ Sell first and buy it back later at lower price.
- You BORROW the shares from your broker who BORROWS them from the desringhouse
- A BUYER has to be on the other side of the transaction-they are BUYING the shares you are SELLING

Why Short?

- Markets (traders) always overreact
- Stocks fall faster than they rise
- Selling always inevitable; buying is not
- Longs taking profit always create shorting opportunities
- · Stocks very rarely close at their daily high
- · Less competition
