Second given that a system of these Labour Managed Firm cooperatives would reverse the capital labour relationship it is suggested that this would constitute a form of market socialism. Third it is argued that compared to capitalism a system of producer cooperatives offers a wealth of advantages including the potential for efficiency gains the eradication of unemployment and the end of exploitation. Ultimately this book concludes that self management could take the place of central planning in Marxist visions for the future.
