TRADITIONAL MARRIAGE

Requirements: Typically requires a marriage license, a ceremony witnessed by an authorized official, and registration with the state.

Common-Law Marriage

Recognized in some states, common-law marriage does not require a formal ceremony or marriage license but involves cohabitation and presenting as married to the public.

Requirements: Must live together, intend to be married, and hold themselves out publicly as married.

State Recognition (Common Law Marriage Jurisdictions): AZ, HI, IL, IN, MI, NY, OH, RI, SD, TN, TX, VA, WI.

COVENANT MARRIAGE & VOID UNION

Alternatives to marriage with varying legal recognition and rights. These unions are particularly common among same-sex couples in states where same-sex marriage was not initially recognized.

Differences from Marriage: Typically lack federal recognition and may not include all legal protections of marriage, such as tax benefits and social security.

Pre-nuptial Agreements

A prenuptial agreement is a legal contract made before marriage that outlines how assets and debts will be handled if the marriage ends in divorce or death. It is particularly useful in protecting premarital assets, businesses, or to provide for children from previous marriages.

Benefits

- Asset Protection:** Safeguards assets acquired before marriage or those expected in the future.
- Debt Management:** Shields one spouse from the other's debts, preserving credit.
- Clear Expectations:** Sets clear guidelines about financial responsibilities and property division, which can reduce misunderstandings.
