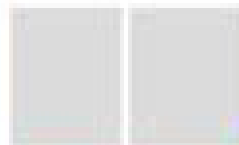
Regulation 101(1) of the Anti-Sexual Harassment Act (ASHA) (1997)

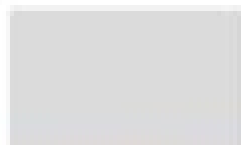
