For the vast majority of defendants, their constitutional rights are irrelevant as they are forced to accept plea bargains or face the prospect of a comparatively harsh sentence if convicted. The prospect of a trial once an important restraint on prosecutors in charging has disappeared and plea bargaining rules.
