Subject to prior notification to BSP ([Annex U](#))

## Investments by banks and quasi-banks

- Not covered by the provisions of the FX Manual
- Subject to prudential regulations of the BSP (e.g., Manual for Banks and Quasi-Banks) and other applicable laws

## Reporting

- Banks to submit to BSP a monthly report ([Annex V](#))
