The present proceedings comprise the papers which were circulated to the participants two months before the symposium and discussed during the symposium together with some comments and additional remarks. These comments and remarks do not, however, represent the full discussions but only the parts available in written form. We have arranged the material in five sections: I. Structure and Neurobiology of the Inner Ear; II. Cochlear Mechanisms; III. Auditory Frequency Analysis; IV. Auditory Time Analysis; V. Nonlinear Effects. Within the limits of a symposium, none of these topics could be treated comprehensively; moreover, most of the papers concerned problems having several aspects.
