Quatremère de Quincy David Gilks, 2024-05-31 Antoine Chrysosth me Quatrem re de Quincy 1755 1849 was the most distinguished writer on art and architecture at the end of the enlightenment However as David Gilks shows in Quatrem re de Quincy Art and Politics during the French Revolution he was never simply an esoteric antiquarian and theoretician he was also a zealous functionary and skilled publicist whose writings on the arts often served political purposes Quatrem re de Quincy Art and Politics during the French Revolution demonstrates how Quatrem re s early writings on art and antiquity formed the foundation for a politics grounded in faith authority and hierarchy that favoured gradual social and political evolution over destruction and experimentation Gilks then traces how Quatrem re set aside his antiquarian research and became a royalist politician and publicist during the revolutionary decade Quatrem re feared that the Revolution would destroy the cosmopolitan republic of letters that had flourished when states across Europe supported the papacy s rediscovery of the past restoration of taste and revival of learning Yet Gilks reveals that Quatrem re was also a resourceful and an opportunistic political actor who deployed his opponents language for strategic reasons Gilks therefore reinterprets Quatrem re s interventions by situating them in their polemical contexts and treating them as contributions to debates and quarrels by locating his sources and reconstructing his social and political networks The resulting study revises our understanding of Quatrem re s famous reflections on the Academy of Painting and Sculpture the Panth on art plunder and museums but it also discovers and sheds light on previously ignored writings Although the study focuses on the period 1789 1799 it examines the second half of Quatrem re s life to substantiate his commitment to crown and altar and show how he fought against the Revolution s legacy of godless materialism and calculation that was inimical to the arts This is a thoroughly researched and richly detailed contextual study of the most eventful period in Quatrem re s life but it also offers an original and unfamiliar history of the French Revolution Gilks integrates the study of political power with the history of ideas and art history and provides a window into institutional and legal reforms and debates about cultural patronage and education

**Controlling Paris** Jonathan M. It is not focused on military tactics so much as on the broader issues involved in controlling civil disorders, relations between the government and its military leaders, causes and social issues of public disorder, political loyalty of troops in crisis and excessive use of force to control civil disorders. Yet somehow despite all these disadvantages the French police and armed forces prevented regime change far more often than they failed to do so.

Jones,2020-12-09 In *The Shattered Cross* Linda Carol Jones explores the lives and work of five priests of the S minaire de Qu bec the first French Catholic missionaries to serve along the Mississippi River between 1698 and 1725 Using an array of archival holdings in Qu bec and France Jones provides deep insight into the experiences of these pioneer priests and their interactions with regional Native peoples and cultures Encounters between early French Catholic missionaries and Native peoples were always complex often misunderstood and typically fraught with an array of challenges As Jones demonstrates these priests faced a combination of environmental personal economic and leadership difficulties that along with cultural misunderstandings and poorly designed strategies made their missionary work arduous Nevertheless their efforts led in some instances to assimilation of select Christian elements into Native cultures albeit through creative mutual adaptation not solely through Catholic efforts In describing the challenges the S minaire priests faced in their Christianization efforts Jones reveals patches of middle ground that served to transform both missionary and Native cultures when least expected She relates the story of Father Marc Bergier who took the openness and compassion he felt for the Native peoples he encountered in Qu bec with him as he descended the Mississippi River and worked among the Tamarois Bergier revealed a willingness to reject certain aspects of Catholic teaching in order to accept various Native traditions Jones also investigates the case of Father Jean Fran ois Buisson de Saint Cosme strongly suspected by church leaders of having an inappropriate interest in women while serving as a priest in Acadie several years before his departure down the Mississippi Jones suggests that Father Saint Cosme s subsequent sexual relations with the sister of the Great Sun of the Natchez may have been an attempt to step into a middle ground with her so as to end the Natchez tradition of human sacrifice upon the death of a Great Sun Expectations of S minaire leaders in Qu bec and Paris meant that those with the best chance for success on the Mississippi were internally driven acknowledged a sense of calling to be a part of the overarching mission of the seminary and adhered to the advice of its leadership The missionary experiences of these five men their varied encounters with Native peoples Jesuit missionaries and French coureurs de bois align and diverge in unexpected ways presenting a mosaic that adds to our understanding of both the tribulations French Catholic missionaries faced and the consequences of their efforts along the Mississippi River in the early eighteenth century Rosa Manus (1881-1942) Myriam Everard,Francisca de

Haan,2016-11-01 Rosa Manus 1881 1942 uncovers the life of Dutch feminist and peace activist Rosa Manus co founder of the Women s International League for Peace and Freedom vice president of the International Alliance of Women and founding president of the International Archives for the Women s Movement IAV in Amsterdam revealing its rootedness in Manus s radical secular Jewishness Because the Nazis looted the IAV 1940 including Manus s large personal archive and subsequently arrested 1941 and murdered her 1942 Rosa Manus has been almost unknown to later generations This collective biography offers essays based on new and in depth research on pictures and documents from her archives returned to Amsterdam in 2003 as well as other primary sources It thus restores Manus to the history from which the Nazis attempted to erase her
