The role of dietary interventions in the regulation of host-microbe interactions: Volume II

Intestinal microbiota, a complex ecosystem of microbes that inhabits and critically maintains homeostasis of the gastrointestinal tract, exerts a major impact on host physiological, nutritional and immunological processes. Among the multiple factors related with intestinal microbiota, diet is regarded as the most important determinants. Dietary intervention mainly regulates the composition of intestinal microbiota by ingesting probiotics/probiotics, dietary fiber, etc., and then improves host immunity, metabolic processes and mutrients bioavailability, inhibits oxidative stress and inflammatory pathways to achieve the purpose of improving bost health. Therefore, in the present Research Topic, we have collected eleven articles related to the regulation of intestinal microbiota and host health through dietary interventions, including nine original research articles, one prospective clinical study and one review in the fields of human systemic diseases (allergy, hyperuricemia, hyperlipidemic), gastrointestinal diseases (colorectal polyps), neurodegenerative diseases (Alrheimer's disease (AD), Parkimson's disease (PD)), and animal husbandry (calves, broiler feed, weaned psighets, chickens).

Systemic diseases are diseases that affect all organs and systems of the body, which are often chronic diseases such as allergy and diabetes. Intestinal microbiota plays an important role in the development of systemic diseases. Based on B-lactoglobulininduced allergy mice model, Tian et al. explored the mechanism of Bifidobacterium animalis KV9 (KV9) and Lactobacillus vaginalis FN3 (FN3) on alleviating allergic
