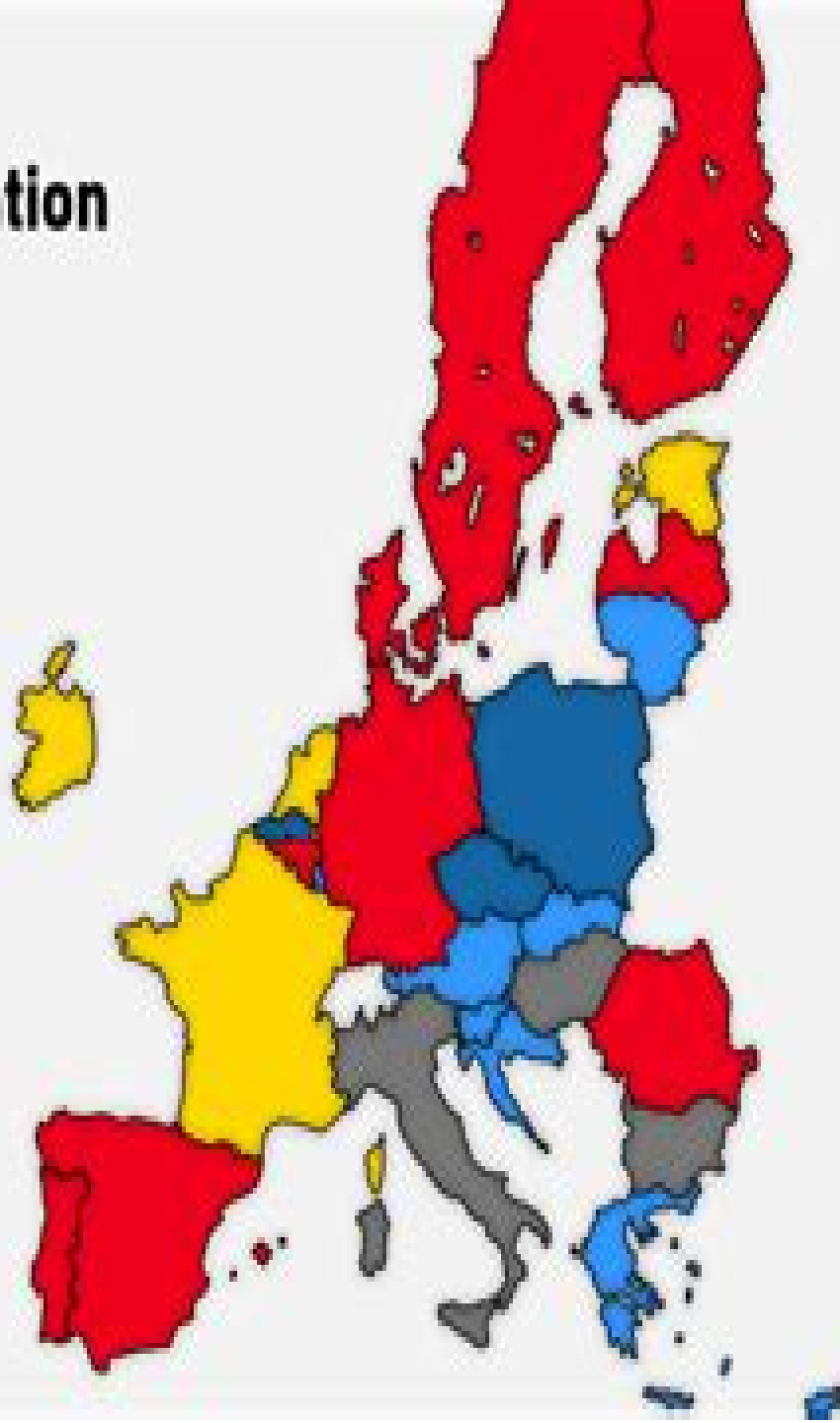
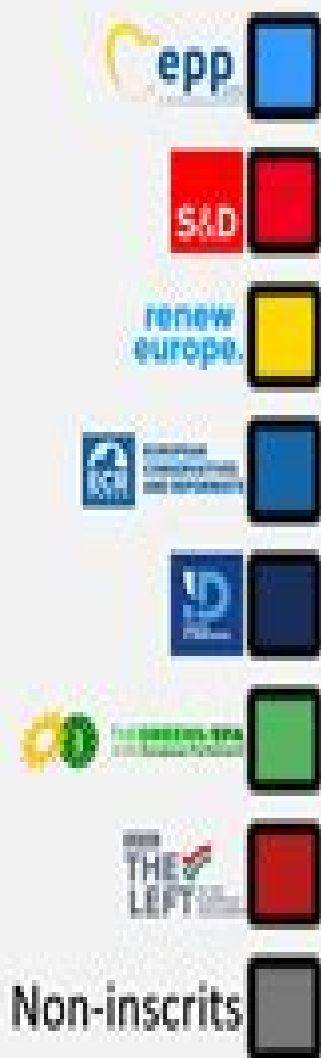


EU map of ruling parties by EU political group affiliation
