

# The Treaties and the Integration Process

- **Since SEA round of treaty reform every 4-5 years:**

- Integration process requires periodic revision;
- Catch up with evolving realities and enable desired development to occur;
- Consequence of governmental bargaining (some governments inevitable disappointed with the outcome of the treaties and start pressing for another round even during ratification);
- The last three treaties – Maastricht – Amsterdam – Nice – have especially provided for further rounds reform.
