The desired outcome is a more efficient market for the provision of electric service ultimately resulting in lower costs to customers This book focuses on impediments to this transformation In partiCular it argues that information control is a form of market power that inhibits the evolution of the market The analysis is presented within the context of the transformation of the US Regulatory Risk: Economic Principles and Applications to Natural Gas Pipelines and Other Industries A.
