- Resource Conservation and Recovery Act
 - Structured to allow states to serve as the “primacy” agency
 - Different from Superfund or CERCLA in that it deals with hazardous wastes on active sites
 - Provides baseline enforcement standards for hazardous wastes from “cradle to grave”
 - States may promulgate more stringent regulations
