The employment effects of a revenue neutral green tax reform are sensitive to institutional arrangements concerning taxation and indexation of unemployment benefits and personal tax allowances A revenue neutral green tax reform will boost employment if unemployment benefits are untaxed and nominally fixed Employment actually falls if unemployment benefits are taxed and price indexed When employment changes the functional distribution of income also changes Total private income after tax profits and after tax labor income increase with employment while transfer income decreases If the polluting good is normal a positive employment effect reduces the environmental dividend obtained from a revenue neutral green tax reform
