Swanson, Tun Lin, 2009 *An Empirical Analysis of the Interactions Between Environmental Regulations and Economic Growth* Chali Nondo, 2009 ABSTRACT The purpose of this research is to examine the relationship between environmental regulation and economic growth A four equation regional growth model is used to analyze the simultaneous relationships among changes in population employment per capita income and environmental regulations for the 410 counties in Appalachia Our results reveal that initial conditions for environmental regulation are negatively related to regional growth factors of change in population per capita income and total employment From this we infer that the diversion of resources from production and investment activities to pollution abatement is inadvertently transmitted to other sectors of the economy thereby resulting in a slow down of regional growth We also find robust evidence that show that changes in environmental regulations positively influence changes in population total employment and per capita income Thus we parsimoniously conclude that in the long run environmental regulations are not detrimental to economic growth Environmental regulation and economic growth Dansk Metalarbejderforbund.
