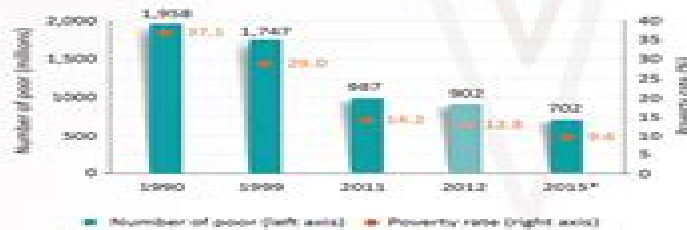

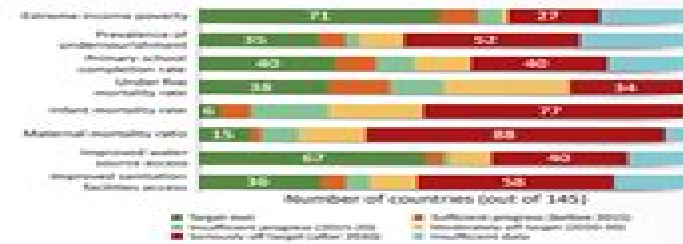

Projections show that the global poverty rate may have fallen to single digits in 2015. Yet, the number of poor remains high.



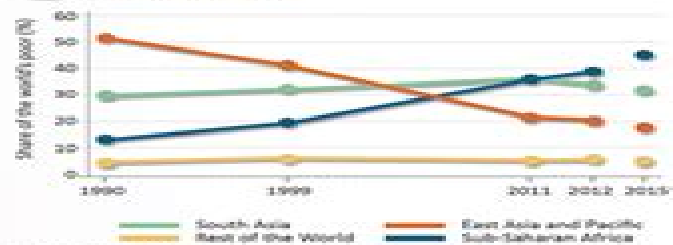

An increasing share of the world's poor reside in Sub-Saharan Africa, requiring increased focus on this continent.



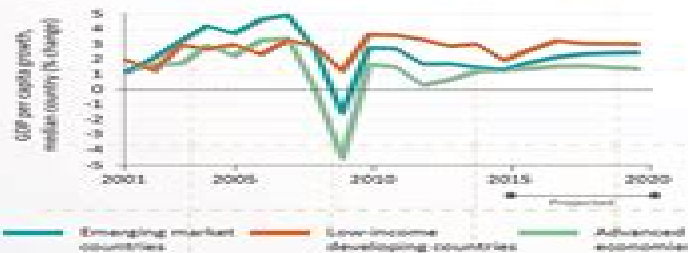

In most countries, income growth of the bottom 40% has been positive – accelerated growth is needed to meet poverty and shared prosperity objectives.



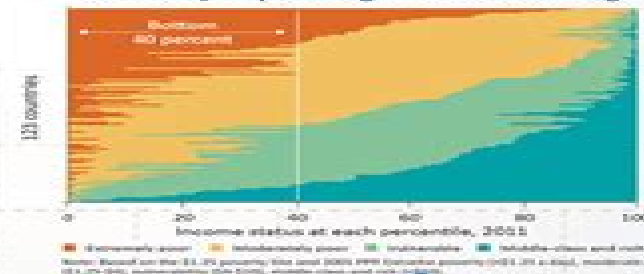
