However, this right is not absolute and can be limited if the government demonstrates a compelling interest that outweighs an individual's religious practice. In cases such as *Reynolds v. United States* (1879) and *Employment Division v. Smith* (1990), the Supreme Court grappled with the limits of the Free Exercise Clause, establishing that neutral laws of general applicability can restrict religious practices as long as they do not specifically target religion.
