unrestructured enterprises or work in the informal sector or resort to subsistence agriculture. Thus underemployment in the CIS is a mirror image of unemployment in the European transition economies. Accordingly the high employment to population ratios in many CIS countries do not necessarily signify favorable labor market performance. Instead they often indicate delayed enterprise restructuring, the maintenance of unsustainable jobs in uncompetitive firms, and the existence of a large informal sector as an employer of last resort. Labor market segmentation has been caused by a sharp increase in earnings differentials and the attendant increase in the incidence of low paid jobs by the polarization of regional labor market conditions and finally by the growth of the informal sector offering casual low productivity jobs. Labor market segmentation and accompanying inequalities are more pronounced in the CIS than in the European transition economies.
