Economic Development in Kazakhstan Anne E. Peck, 2004 Economic Development in Kazakhstan traces the role of large enterprises the core of the country's industrial economy their development through 70 years of socialism and their privatization since 1991 when Kazakhstan became independent Tracing the path of Kazakhstan's expansion to become a competitor in the international economy this book gives hitherto hidden insights into policies which aim at transforming the economy as well as to the individuals who now control parts of the economy and to their political allegiances Although touted as a very aggressive transition strategy Anne Peck suggests that the privatization and sale of main enterprises has led in fact to a surprising degree of control by just a few new investors and increasingly strong insiders Controversially the book concludes that it is the control demanded by these insiders rather than the success of any foreign investor that will ultimately determine the future development of the country's economy With many empirical examples of what the process of industrial privatization means to individuals as well as to communities this book will be of interest to professionals and business people connected to the region

The Political Economy of Reform in Central Asia Martin C. Spechler, 2008-04-23 This book examines the economic reforms and material progress made since the Central Asian republics became independent from the Soviet Union in 1991 Without some of the neo liberal reforms recommended by the Washington Consensus and with an authoritarian presidency Uzbekistan the largest of these countries has nevertheless achieved modest economic growth stability and a relatively impressive degree of income equality The country has also preserved its economic and political independence from the great powers Russia China and the USA who are rivals for influence and energy in Central Asia Human rights have been poorly enforced though occasional thaws have also taken place In second half of the book features a comparative analysis of four Central Asian states all super presidential authoritarianisms but with very different resource endowments and external commitments A separate chapter deals with the energy resources of the region and the challenges of bringing oil and gas to the world market and the question of whether Central Asian states will return to the Russian sphere of influence or seek closer ties with Asia or Europe is examined The book concludes with prospects for future political and economic progress in the key Central Asian states

from below 10 in 1998 to 70 in 2006 This book analyzes the experience of the Caspian countries during the oil boom It is founded on empirical studies using either macroeconomic tools or an analysis of public budgets or microeconomic analysis of household survey data or fieldwork in oil producing regions Moving from aggregated to disaggregated analysis and in keeping with its emphasis on rigorous empirical analysis to the greatest extent possible several chapters are written by specialists on the Caspian region Whilst there is an emphasis on the economic consequences of the oil boom the interdisciplinary aspects of the phenomenon are also recognized Overall the analysis is firmly rooted in the region yet the empirical studies also provide a basis for drawing broader lessons about the effects of an oil boom
